## SUMMARY OF INCIDENT:

On the above mentioned date and time members of the Connecticut State Police, along with numerous other municipal and federal law enforcement agencies responded to an active shooter call at the Sandy Hook Elementary School, located at 12 Dickinson Drive, Newtown, Connecticut. As part of this investigation several law enforcement officers were tasked with death notifications to the families of the victims.

## ACTION TAKEN:

On Saturday, December 15th, 2012 at approximately 0025 hours, this investigator, along with Catherine Scheidel and Christopher Young from the Wellmore Behavioral Services went to 03 12 100 the parents of victim 101 02 03 12 100 that their daughter died on 12/14/2012 at the Sandy Hook School shooting. The parents were provided with information on victims services.
