ACTION TAKEN:

On 12/16/12 at approximately 1200 hours, Detective VanNess was assigned to assist Victim Specialist Ashley Hall from the FBI's Victim's Services Unit in speaking to the family of [REDACTED] 01 02 03 12. Upon their arrival, the home was dark and it appeared as if nobody was home. Hall left a voicemail message on the home phone for the [REDACTED] 01 02 03 12 to contact her.

At approximately 2015 hours, I was assigned to accompany Hall on a second visit to the [REDACTED] 01 02 03 12 residence. Upon arrival at approximately 2030 hours, we were greeted at the front door by [REDACTED] 01 02 03 12. After identifying ourselves, [REDACTED] 01 02 03 12 invited us into the house. Upon entering the house we were introduced to his wife, [REDACTED] 01 02 03 12 and [REDACTED] 01 02 03 12. Hall informed the family of the services which were available through her office and later provided them with the Victim's Compensation Forms which needed to be completed in order to receive assistance.

On 12/20/12 at approximately 1330 hours, I was assigned to contact the [REDACTED] 01 02 03 12 family to determine if [REDACTED] 01 02 03 12 would be willing to give a statement as to what [REDACTED] 01 02 03 12 may have mentioned to them about the shooting incident. I also advised them that if [REDACTED] 01 02 03 12 wanted to speak to police about the incident, a forensic interview could be arranged. [REDACTED] 01 02 03 12 indicated that they would need some time to discuss it privately and then they would contact me with their decision.

On 12/20/12, I was assigned to transport [REDACTED] 01 02 03 12 to the memorial wake for [REDACTED] 01 02 03 12. Detective Kiely and I took them to the wake at [REDACTED] 01 02 03 12. Upon returning [REDACTED] 01 02 03 12 to their residence at approximately 1700 hours, [REDACTED] 01 02 03 12 informed me that they would like to have [REDACTED] 01 02 03 12 forensically interviewed as they believed it would be helpful in her healing process. I advised [REDACTED] 01 02 03 12 that somebody would contact her to arrange the interview.
