On December 20, 2012, this Trooper was directed to go to the Sandy Hook Elementary School to retrieve personal items that belonged to [REDACTED] [01 02 03 12] was a first grade student who was killed in the school shooting. This Trooper took possession of two boxes containing personal items belonging to [REDACTED] [01 02 03 12] from Connecticut State Police Sergeant Michael Decesare.

This Trooper also picked up two boxes of personal items belonging to [REDACTED] [01 02 03 12]. This Trooper returned the two boxes of items belonging to [REDACTED] [01 02 03 12] to Sgt. Decesare when it was revealed the [REDACTED] [01 02 03 12] family had [REDACTED] [01 02 03 12].

On December 21, 2012, this Trooper gave the two boxes which contained [REDACTED] [01 02 03 12] personal items to [REDACTED] [01 02] [REDACTED] was assigned as the family liaison for the [REDACTED] [01 02 03 12] family.

This case will remain open pending further investigation.
