ACTION TAKEN:

On 12/14/12 while on scene of Sandy Hook Elementary School where a school shooting had occurred, I was assigned as the liaison to the family of 01 02 03 12, a first grade student of Amanda D'Amato's class whom had not been located along with several others. I was assigned to meet with the family to obtain a physical description of the victim, a photograph of the victim if possible, as well as any other pertinent information, to assist the medical examiner in the positive identification of each victim.

I met with 01 02 03 12, parents of 01 02 03 12 at the Sandy Hook Firehouse where I was provided a recent color school photograph as well as a detailed description of 01 02 03 12.

Shortly after I collected the above stated information the families were advised that there were no surviving children inside the school. At this time the 01 02 03 12 family returned to their residence pending identification of their son.

On 12/15/12 between 0030 and 0100 I went to 01 02 03 12 accompanied by Deacon Joseph Gill of the Church of St. Mary and Counselor Lauren Lavoie, Licensed Professional Counselor of Clifford Beers in New Haven, for the death notification of their son, 01 02 03 12. Notification was made to both 01 02 03 12.
