Action Taken: On 12/14/12 this Trooper was assigned as the liaison to the family of **01 02 03 12** a first grade student in Amanda D'Amato's class, had not been located. This Trooper was assigned to collect identifying information and a photograph of **01 02 03 12** parents were identified to be **01 02 03 12**. Shortly after this Trooper collected the above stated information the families were advised that there were no surviving children inside the school. While at the Sandy Hook Firehouse, the **01 02 03 12** in Newtown.

This Trooper advised the **01 02 03 12** that the identification process may take some time and that it may be advisable to return to their residence. **01 02 03 12** were driven home by **01 02 03 12**. The **01 02 03 12** were provided with this Trooper's cell phone number. This Trooper maintained contact with the **01 02 03 12** throughout the evening and at one point stopped at the residence for additional information.

On 12/15/12 at approximately 0040 hours, this Trooper went to the **01 02 03 12** for the death notification of their daughter, **01 02 03 12**. This Trooper was in the company of Pastor Robert Morris, Dr. Marcy Kane (Vice President Child services, Wellmore Behavioral Health), and Courtney Litowitz (FBI victim services).
