Action taken: On 12/14/2012, at about 2330 hours, I (Tpr. Murchison #1127) was given the task of performing an official notification of the death to the parents of [REDACTED] 01 02 03 12).

Prior to the official notification by the Connecticut State Police, I was briefed by command staff at the Sandy Hook Volunteer Fire Department, located on Riverside Road, in the Sandy Hook section of the Town of Newtown. I was provided an information packet containing information to assist the family as well as logistical information needed for myself to conduct the official notification of death. The logistical information provided the names of the parents, date of birth and address of [REDACTED] 01 02 03 12 . The parents were identified as [REDACTED] 01 02 03 12

The parents were [REDACTED] 01 02 03 12 I secured clergy from the church as well as a social worker to assist with the notification. Father Luke from St. Rose of Lima Church and Juliet Gurevitz, a social worker from Silver Hill Hospital were secured for the notification.

[REDACTED] 01 02 03 12 Sgt. Desmarais #0100 and Tpr. Ouellette #0993 went to the airport to provide an escort back to the residence at [REDACTED] 01 02 03 12 . At approximately 0250 hours on 12/15/2012, I met Sgt. Desmarais and Tpr. Ouellette at the residence.

At approximately 0300 hours on 12/15/2012, in the presence of Sgt. Desmarais, Tpr. Ouellette, Fr. Luke and Juliet Gurevitz, I made the official death notification to [REDACTED] 01 02 03 12 of the passing of their daughter, [REDACTED] 01 02 03 12 on 12/14/2012 while she was
