ACTION TAKEN: On 12-15-12 at approximately 1200 hours I, Trooper Hunter #601 along with FBI Victim Program Specialist Kathleen D. Hall reported to a private residence located at [REDACTED] 01 02 03 12 in the town of Newtown to make a Notification of Death to [REDACTED] 01 02 03 12 who is the mother of deceased Sandy Hook Elementary School student [REDACTED] 01 02 03 12

Kathleen Hall and I spoke with [REDACTED] 01 02 03 12 in front of her aforementioned residence and in speaking with her notified her that her son, [REDACTED] 01 02 03 12 was in fact among the deceased who were found inside the Sandy Hook Elementary School after an active shooter incident that took place there on the morning of 12-14-12.

[REDACTED] 01 02 03 12 informed us that personnel from the Connecticut State Police had reported to her residence the previous evening to notify her of the death of her son but she had been asleep at the time of their arrival and was notified of his death by her mother later in the night.

[REDACTED] 01 02 03 12 the father of their aforementioned deceased child was also on scene when this death notification was made however [REDACTED] 01 02 03 12 had already been notified of said death the previous evening by personnel from the Connecticut State Police while he was in the Command Post staging area at the Sandy Hook Fire Department.

CASE STATUS: Active.
