ACTION TAKEN:

On 12/14/12 this Officer was assigned as the liaison to the family of Dawn L. Hochsprung (DOB 06/28/1965). Dawn Hochsprung, was the principal at Sandy Hook Elementary School, and had not been located. This Officer was assigned to collect identifying information and a photograph of Dawn Hochsprung.

Dawn's family members were identified to be 04 [REDACTED] CT also there was 04 [REDACTED]. Shortly after this Officer collected the above stated information the families were advised that there were no surviving people inside the school.

This Officer advised the family that the identification process may take some time and that it may be advisable to return to their residence. 04 [REDACTED] went to his home in 04 [REDACTED] while 04 [REDACTED] went to their house in 04 [REDACTED]. This Officer maintained contact with the Hochsprung family throughout the evening, advising them on any updated information this Officer received.

On 12/15/12 at approximately 0050 hours, this Officer went to [REDACTED] 04 [REDACTED] located at 04 [REDACTED] CT for the death notification of, Dawn Hochsprung. This Officer was in the company of three social services victim advocates, Christine Montgomery, Ragne Adams and Pam Herbet. When this Officer arrived at the residence I was greeted by 04 [REDACTED], he invited this Officer inside his residence where he introduced [REDACTED] 04 [REDACTED]. This Officer advised [REDACTED] 04 [REDACTED] that Dawn Hochsprung died as a result of the Newtown shooting at Sandy Hook Elementary School. [REDACTED] 04 [REDACTED] was given victim services packet along with forms for family members to receive financial compensation. This Officer cleared the residence at 0145 hours on December 15, 2012.
