Notification for **01 02 03 12**

**ACTION TAKEN:**

That on 12-14-2012, I was assigned with Anthony Colombrito of the Department of Mental Health and Pastor Wil Marotti to make a death notification to the parents of **01 02 03 12**, concerning the shooting at Sandy Hook Elementary School in Newtown, Connecticut on 12-14-2012. **01 02 03 12** was a 1st grade student in Amanda D'Amato's classroom.

That on 12-15-2012 at approximately 0030 hours, we arrived at **01 02 03 12**, the residence of the **01 02 03 12** family. I knocked on the front door and a male answered the door, later identified as **01 02 03 12**, the father of **01 02 03 12**. I introduced myself, Anthony Colombrito and Pastor Wil Marotti and then asked **01 02 03 12** if his wife was home. He stated yes and I then asked him if he would be able to get her. **01 02 03 12** then asked to enter his home and we all waited in the kitchen/family room area as he went to the back of the house and came back with a female, later identified as **01 02 03 12**, the mother of **01 02 03 12**. I then introduced myself, Anthony Colombrito and Pastor Wil Marotti to **01 02 03 12**. I then informed them that their son, **01 02 03 12** had died in the incident at the Sandy Hook Elementary School. I then informed them that their son, **01 02 03 12** would be going to the Chief Medical Examiners Office in Farmington. I then asked them if they had made any kind of arrangements concerning their son as of yet. **01 02 03 12** stated yes and stated they were using the funeral home **04**, who was a good friend of theirs. I then informed her that they just needed to inform the funeral home where **01 02 03 12** was and they would take care of the rest. I then gave them the paperwork from the Federal Victim Service Unit and my personal telephone number if they had any additional questions they might have.
