ACTIONS TAKEN: On 12-14-12, at approximately 2100 hours, I arrived at the CSP Command Post located at 18-20 Dickinson Drive, in Newtown. My initial responsibilities were to assist with scene security, specifically keeping the media outside of the established perimeter, located at the firehouse at the corner of Riverside Road and Dickinson Drive, in the Town of Newtown.

At approximately 2300 hours, I was notified that I would be a member of a notification team and would be delivering an official death notification of one of the victims. This notification team consisted of State Police Chaplain Rev. Edward Goetz, Clinical Psychologist Vincent Frando, Trooper Lavoie #840, and I. On 12-15-12, at approximately 0035 hours, my notification team arrived at [REDACTED] 01 02 03 12 in the Town of Newtown, to deliver the death notification of [REDACTED] 01 02 03 12. I delivered said notification to [REDACTED] 01 02 03 12, the parents of the deceased. The [REDACTED] 01 02 03 12 were provided information regarding victim's services, as well as contact information for the CSP Command Post and the OCME. In accordance with the [REDACTED] 01 02 03 12 family's wishes, this notification team departed from the residence approximately 15 minutes later.
