ACTION TAKEN: On December 14, 2012, I was assigned by the Troop I Supervisor, Sgt. Park to report to the Command Post in Newtown in the area of the Volunteer Fire Department for 2100 hours.

Upon arrival, I was assigned by the Command Post Supervisor to cover a post in the front of the Sandy Hook Volunteer Fire Department to keep media and other non authorized personnel from entering the State Police perimeter.

I assisted Major Fox #013 by driving to the St. Rose of Lima Roman Catholic Church in Newtown to locate clergy personnel to assist in death notifications.

I was assigned to perform a death notification at [REDACTED] 01 02 03 12 in Newtown. On December 15, 2012 at approximately 0045 hours, I spoke to [REDACTED] 01 02 03 12 the father of [REDACTED] 01 02 03 12 and made the official death notification. [REDACTED] 01 02 03 12 were also present during the death notification. [REDACTED] 01 02 03 12 was identified by his Connecticut operator's license. [REDACTED] 01 02 03 12 was provided with information that was distributed by the State Police Supervisors at the Command Post.
