ACTION TAKEN: On the evening of 12/14/2012 I was ordered to report to the command post at the Sandy Hook Fire Department. Upon arrival I was directed to make the death notification of Lauren Rousseau (D.O.B. 06/08/1982) to 04 [REDACTED]. Also assigned to assist me with this assignment were specialists Mary Moore from the Red Cross Rhode Island office, John Perotti from the CT Department of Mental Health Meriden office and Dana Hallenbeck who is the Troop H Pastor.

Myself, Moore, Perotti and Hallenbeck drove from the command post in my assigned cruiser (bearing CT registration 101UTZ) to the 04 [REDACTED] CT. On 12/15/2012 at approximately 0045 hours I met with 04 [REDACTED] at his residence. 04 [REDACTED] was sleeping at the time and was awoken by my knocking at his door. 04 [REDACTED] was formally informed that 04 [REDACTED] was deceased and that she has been positively identified through photographs. 04 [REDACTED] stated he was still numb to the whole thing. 04 [REDACTED] stated 04 [REDACTED] stated he has been in contact 04 [REDACTED]. I offered to visit 04 [REDACTED] and formally inform her but was told that wouldn't be necessary. 04 [REDACTED] stated he was under the impression he was assigned one Trooper to deal with and didn't understand why he was now dealing with someone else. After asking basic questions about Lauren Rousseau the said specialists tried to console 04 [REDACTED] stated he did not want any of their services that night. On 12/15/2012 at approximately 0100 hours we left the residence and returned to the command post. All pertaining paperwork was left with a supervisor.
