ACTION TAKEN:

On the evening of 12/14/2012 I was ordered to report to the command post at the Sandy Hook Volunteer Fire Department. Upon arrival I was directed to make the death notification of [REDACTED] 01 02 03 12) to his parents, [REDACTED] 01 02 03 12 [REDACTED]. Also assigned to assist me with this assignment was specialist from the American Red Cross, Wayne Dailey and State Police Chaplain, Father Kevin Donovan.

Daily, Father Donovan, and I drove from the command post in my assigned cruiser (bearing CT registration 988UTZ) to the [REDACTED] 01 02 03 12 residence located at [REDACTED] 01 02 03 12. On 12/15/2012 at approximately 0140 hours I met with [REDACTED] 01 02 03 12 at their residence. [REDACTED] 01 02 03 12 were formally informed that their son [REDACTED] 01 02 03 12 had positively been identified via photographs and was confirmed deceased. We remained with the [REDACTED] 01 02 03 12 family at their residence for a period of time before returning to the command post.

All pertaining paperwork was left with a Sgt Eters #0154.
