That on 12^{01 02 05}/12 at approximately ^{01 02 03 12} hours, I responded up to the firehouse to get changed for a wake for victim/ ^{01 02 03 12}. I assisted in this process as ^{01 02} was the family liaison and had been working 18-20+ hours/day for over a week. ^{01 02} as the ^{01 02}. At approximately ^{01 02 03 12} hours, we met at the residence of ^{01 02 03 12} in Newtown. A significant police presence was formed by Woodbridge, Stamford, State Police and others for this escort.

We arrived at ^{01 02 03 12} and assisted however we could during this difficult time. During the services, Tfc. J. O'Connor #1036 asked me if he could bring his K-9 inside the church for the kids. Tfc. O'Connor had previously used his K-9 with the kids the night before. I advised him to bring the K-9 inside the crying room (rear of church). He did so and brought such joy to the kids of this family. From siblings to cousins they were all enamored. The parents appreciated this gesture of kindness also as they could focus on each others needs and not chase their kids around the church. After 5+ hours of people coming to the wake, it ended.

On 12^{01 02 05}/12 at approximately ^{01 02 03 12} hours, we met again at ^{01 02 03 12} to attend the Mass /Funeral for ^{01 02 03 12}. We attended with Respect for this damaged family. Many Officers stayed for the Mass and provided security for the family to grieve privately. The services lasted for over 1 hour. ^{01 02 03 12} arrived on scene to escort ^{01 02 03 12}
