During the early afternoon hours on December 14, 2012, I was assigned to act as the liaison trooper with the parents of **01 02 03 12** presumably one of the victims of the Sandy Hook Elementary shooting. I was instructed to obtain a physical description of **01 02 03 12** which would aid in identifying her as one of the victims. Furthermore, I was instructed to act as a reference or conduit with regards to questions the **01 02 03 12** may have regarding the ongoing investigation and tend to the families personal needs.

At approximately 13:35 hours I introduced myself to **01 02 03 12**. I informed them I had been assigned as their law enforcement liaison and explained my duties. Subsequently, I obtained a physical description of **01 02 03 12** and obtained a description of the clothing she wore. **01 02 03 12** provided the following information: **01 02 03 12**
01 02 03 12. She is a first grade student in Amanda D'Amato's class. (See original notes attached)

At this time I inquired if either **01 02 03 12** had a photo of **01 02 03 12** that they could e-mail me. **01 02 03 12** located a photograph on his cell phone and e-mailed it to my assigned FBI e-mail account. The photograph depicted **01 02 03 12** sitting on a tire swing (see printed copy attached).

Captain Fusaro subsequently re-assigned me to assist Major Crime at the school crime scene and act as a forward crime scene liaison with the established command post.

I informed **01 02 03 12** of my newly assigned duties. I introduced them to **01 02**, who would assume the liaison activities.
