CTIC subsequently fulfilled my request and e-mailed D.M.V. license photographs of the aforementioned victims. Printed photographs were delivered to Sgt. James Thomas, Major Crime, who was in the temporary mobile morgue conducting victim identifications. (See attached printed DMV license photographs of victims) I subsequently aided in the identification of Dawn Hochsprung who was personally known to me.
