The meeting was opened by Lt. DelVecchia with a moment of silence in memory of those lost in the tragedy at Sandy Hook Elementary.

It was explained to all persons in the room that the information being relayed at the meeting was not for public release, and that it was respectfully being requested that the information was kept in confidence.

A basic timeline of events, in part, beginning with the fact that the doors of the school are locked at 9:30 a.m., and ending with the fact that a radio transmission from a Newtown PD Officer, stating that there was 1 suspect down, was received at 0951 and 31 seconds, was verbally provided (see attached timeline).

Additional information and facts pertaining to the investigation were verbally provided as well (see attached notes).

There were several questions asked and answered by the friends and family members and Lt. DelVecchia prior to the completion of the meeting.

The parents were provided with information pertaining to the Office of Victim Services, as well as a list of services offered by citizens wishing assistance from the Department of Mental Health (see attached). Additionally, it was explained that contact information for the IRS was available pertaining to any suspicious activity surrounding the Social Security Numbers of any of the decedents would be forwarded to each family. Sealed envelopes addressed to each family from the Department of Mental Health, later learned to contain certificates indicating that a tree had been planted in honor of their loved one, were also presented to each family present.

The status of the case remains actively under investigation.

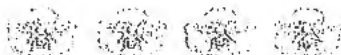

## Toll-Free Number Established For Offers Of Help For Newtown

A toll-free number has been established to make it easier for people to call with offers of help to the community of Newtown, Connecticut. The toll-free number – 855-364-6600 – will be staffed by local Newtown volunteers and supported by the United Way of Connecticut state 2-1-1 Infoline.

The toll-free number was established to assist local officials who were being flooded with phone calls and emails from people asking how they could help Newtown in its time of crisis.

A call center organized by the Newtown Volunteer Task Force, a local citizen's group led by Kevin and Robin Fitzgerald, will handle the toll-free calls from people offering assistance, as well as follow-up directly with those people who called local officials and organizations offering help in the first week of the tragedy at Sandy Hook Elementary. "We have had so many people from around the country and the world offering to help our Newtown community, and their generosity is overwhelming and deeply appreciated," said Mr. Fitzgerald. "We hope this toll-free number and local call center will make it easier for people to contact our community and to direct them on the best way they can help."

People calling the toll-free line can talk to someone who will take information on their generous offers of time, gifts, services, skills and money. The volunteer task force will help connect those offers of assistance to those in Newtown, including local officials, who are working with appropriate organizations and the families of victims to ensure that the offers of assistance will have the maximum benefit for those in need. Fitzgerald noted that the call for volunteers has received a tremendous response from people in Newtown and the surrounding area. People from all walks of life, from many, many organizations, and all political affiliations are signing up with the volunteer task force as another way to help the community. He noted that the support of town and school officials has been essential to the volunteer effort.

Fitzgerald thanked local Newtown businessman Peter D'Amico for providing office space for the local volunteer support and call center, and AT&T, Best Buy, CDW, Charter Communications, Verizon, and Quill.com for providing telecom and Wi-Fi infrastructure and equipment and office supplies. He also thanked the United Way of Connecticut state 2-1-1 Infoline, which is supporting the work of local volunteers by handling calls to the toll-free line on a 24-hour basis. He credited officials of the American Red Cross, the United Way of Western Connecticut, The Network Support Company, and the State Division of Emergency Management and Homeland Security with providing critical guidance and expertise in helping to establish the toll-free number, and the local volunteer call center to support it in coordination with the 2-1-1 service.
