SSN Protection Memo.

The 01 02 03 12 had several questions including the following:

- Where the guns and ammo came from?
- What exactly were ^{01 02 03 12} injuries?
- Was anymore of 01 02 03 12 property available to be returned?
- What will become of the school and the shooter's house and when?
