--- FAMILY MEETING REPORT ---

01 02 03 12 (01/25/13)

ACTION TAKEN:

On 01/25/13 at approx. 0910 hrs., Det. Rachael Van Ness #1431 and I met with the family of 01 02 03 12. 01 02 03 12 was a student in Miss Soto's classroom and a victim of the Sandy Hook Elementary School shooting. Present for this meeting were the following:

The 01 02 03 12 had attended the Group Family Meeting held on 01/15/13 and therefore had received the information that was directly provided by the State Police during that meeting (refer to Group Family Meeting Report). As in that meeting, 01 02 03 12 appeared to take detailed notes during this meeting on his iPad.

Det. Van Ness and I told the 01 02 03 12 where 01 02 03 12 was found by 1st responders. Det. Van Ness had gotten prior approval from 04 to share with the 01 02 03 12 where 04 Anne Marie Murphy was located in proximity to 01 02 03 12, since 01 02 03 12. We explained to the 01 02 03 12 that it appeared that Anne Marie had tried to protect 01 02 03 12 and that they were found together. We also explained that

we were not disclosing any information about any one specific victim until we had first met privately with that family and provided that information to them and received their approval to share that information with others. The 01 02 03 12 approved to the release of 01 02 03 12 location information. In addition, we asked that the information that we discussed be kept in confidence especially since a majority of it had not been disclosed publicly. We also provided the 01 02 03 12 with the I.R.S. SSN Protection Memo.

The 01 02 03 12 had several questions including the following:

- Where the guns and ammo came from?
- What exactly were 01 02 03 12 injuries?
- Was anymore of 01 02 03 12 property available to be returned?
- What will become of the school and the shooter's house and when?

Det. Van Ness and I answered these and other questions the best we could at that time and also told them that we would get back to them with additional information. The 01 02 03 12 also expressed [REDACTED] 01 02 03 12

We also offered again that the 01 02 03 12 could visit the Sandy Hook Elementary School and also receive 01 02 03 12 clothing or a swatch of it if they wanted.

The 01 02 03 12 also informed us that they would be [REDACTED] 01 02 03 12
[REDACTED] Det. Van Ness and I provided them with our contact information before departing at approx. 1000 hrs. The information from this meeting was then tracked on the Family Folder Checklist in their individual Family Folder.
