ACTION TAKEN: On 12/14/12 while on scene at Sandy Hook Elementary School, where a school shooting had just occurred, I was asked by Sgt Van Ness #138 to meet with the D'Avino Family. The D'Avino Family arrived at the Sandy Hook Firehouse sometime after 3:00 PM to attempt to locate Rachel D'Avino.

I was informed by her family that she had recently began a job at the school, approximately a week and a half prior. They were pretty confident she was in the school that day, and that they could not make contact with her. They provided me with her vehicles registration and I located the vehicle in the main parking lot in front of the school. After I confirmed this with her family I obtained a detailed description of her, as well as a photograph, which I provided to Cpt Hourigan #028.

Later in the evening, prior to making death notifications, I provided Tpr Koeppel #1441 with the family's names and contact information as she was to make the death notification of Rachel D'Avino.

CASE STATUS: This case is active.
