On 12-14-12 at approximately 1800 hours I was assigned to respond to the Sandy Hook Elementary School, Dickinson Dr, to assist with scene security following the shooting incident from earlier that day. At approximately 2300 hours I was directed to respond to the Fire Dept and was provided with a packet. I was assigned to respond to [REDACTED] 01 02 03 12, to make death notification to the parents of [REDACTED] [REDACTED]

I proceeded to said address accompanied by Father Luke (clergyman), Brian Gibbins (crisis counselor), and FBI agent Bernardo Curra. Upon arrival at the residence notification of [REDACTED] 01 02 03 12 death was made by myself to [REDACTED] 01 02 03 12 in the kitchen area at approximately 0045 hours on 12-15-12. Family friends, [REDACTED] 04, were present for support. The [REDACTED] 01 02 03 12 were provided with information concerning the medical examiner's office and various services available to them. The [REDACTED] 01 02 03 12 were receiving support from their friends and we cleared the residence shortly thereafter.
