ACTION TAKEN: On 12/14/12 at approximately 1330 hours, I was assigned by the Troop 'C' desk person, TFC Taylor (#0838), to respond to the scene of a school shooting that occurred earlier on this date at the Sandy Hook Elementary School located at 12 Dickinson Drive in the Sandy Hook section within the Town of Newtown, CT. Additional Troop 'C' personnel from the day shift were also assigned to respond to the school.

Upon arrival to the area, I went to the Sandy Hook Volunteer Fire Department located at the intersection of Riverside Road and Dickinson Drive in the Sandy Hook section of Newtown, which was in close proximity to the school. Numerous police and fire department members were present as were numerous family members of children and adults unaccounted for from within the school.

I was assigned to be a family liaison by Major Hyatt (#0014) and Captain Hourigan (#0058). I was assigned to the family of 01 02 03 12 01 02 03 12 had been assisting the parents, prior to my arrival. 01 02 03 12 I would be in contact with the family for the next few days assisting them with anything that they needed as this incident's aftermath unfolded. The grant family did not ask for very much assistance and grieved privately with family members within their residence.


On 12/21/12 at approximately 1230 hours, I met with Lt. Sticca (#0070) at the Sandy Hook Volunteer Fire Department regarding returning personal property retrieved from the school belonging to 01 02 03 12. I was directed to obtain the property from within the school from WDMC squad detectives. I was given two boxes containing items. One box was personal belongings and the other was school work recently completed by 01 02 03 12 I was informed to have a family member sign the JD-CR-18, Property Seized w/o a Search Warrant, form and return it to the office
