Action Taken: On 2/6/13, this Detective met with New Haven based United States Postal Inspector Jason Bourdeau at the Troop A barracks, 90 Lakeside Road, Southbury, regarding the ongoing investigation.

Bourdeau gave this Detective a piece of mail which had been observed by postal staff to have a return address indicating that it may have been written by one of the victims of the Sandy Hook Elementary School shooting on 12/14/12. It was explained that the envelope had filtered through the mail stream until it was observed by another postal employee who recognized the surname as being the same as one of the deceased victims and pulled the mail for further inspection. Upon determining that the envelope had been mailed by one of the deceased S.H.E.S. students, it was flagged for return to the family and turned over to the CT State Police.

The aforementioned piece of mail was given to the assigned CSP family liaison, 01 02 who turned it over to the family at their residence on 2/6/13.

The status of the case remains actively under investigation.
