ACTION TAKEN: On 03/16/13 I received the supplemental report from **01 02**, Weston PD, regarding the death notification of **01 02 03 12**, a child victim of the SHES shooting on 12-14-12. **01 02** stated that, on 12-14-12, he was assigned as a Family Liaison Officer to the **01 02 03 12** Family by the Connecticut State Police. That on 12-14-12, **01 02**, SGT Brodacki (Weston PD), and Reverend Cory Piccinino made notification of the death of their daughter, **01 02 03 12** Refer to attached report.

CASE STATUS: This case remains active pending further investigation.

On the morning of December 14th 2012 I responded to assist the Newtown Police Department for a suspected shooting at the Sandy Hook Elementary School in Sandy Hook (Newtown) Ct. As part of my duties I was assigned as a Family Liaisons Officer to the 01 02 03 12 family by the Connecticut State Police who was in command of the incident. 01 02 03 12 was a student in the school at the time of the shooting and was suspected to be a victim inside the school. I conducted an interview of 01 02 03 12 parents identified as 01 02 03 12 provided a photograph of her daughter 01 02 03 12 and a description of the clothing she was wearing when she dropped her daughter off at school this morning. 01 02 03 12 was wearing a 01 02 03 12 The information I gathered was given to the Investigative Team of the Connecticut State Police and based upon the information provided they confirmed 01 02 03 12 had been shot and killed inside the school.

Shortly after the confirmation was made by the State Police, Sgt. Brodacki, Rev. Cory Piccinino from St. Mary Church in Bethel and I went to the 01 02 03 12 residence. We informed 01 02 03 12 and their awaiting family members that 01 02 03 12 was a victim of the shooting and had not survived. The family was advised to contact the State Medical Examiners Office in the morning for further information regarding the release of their daughter to the Funeral Home. On the morning of December 15th I made contact with Director
