ACTION TAKEN: On 12/14/2012 at approximately 1330 hours, I was assigned to assist [REDACTED] 01 02 03 12 who had arrived at the firehouse and were unable to locate their daughter [REDACTED] 01 02 03 12. I spoke to [REDACTED] 01 02 03 12, who informed me that [REDACTED] 01 02 03 12 was a first grade student in Mrs. Damato's classroom at Sandy Hook Elementary School. They provided me with a recent photograph of [REDACTED] 01 02 03 12 and informed me that she was wearing the following on 12/14/2012: [REDACTED] 01 02 03 12. They also informed me that [REDACTED] 01 02 03 12. I do not recall the exact time, but at some point during the day of 12/14/2012, I was assigned as the Family Liaison to the [REDACTED] 01 02 03 12 family. I remained with and assisted this family throughout the day. At approximately 1500 hours, [REDACTED] 01 02 03 12 left the firehouse and returned to their residence.

On 12/15/2012 at approximately 0045 hours, I went to [REDACTED] 01 02 03 12 with Clinician Caroline Diemar, Clinician David Cribbini, and Monsignor Robert Weiss. I met with [REDACTED] 01 02 03 12 and provided the notification that their daughter, [REDACTED] 01 02 03 12 had been killed at the Sandy Hook Elementary School on 12/14/2012.
