----Family Meeting Report----

01 02 03 12

Action Taken: On 4/17/13 at approximately 1730 hours, this Detective, Detective Jewiss# 336, Tpr. Sawyer #340, Officers Silver and Chapman from the Newtown Police Department and FBI Victim Specialist Ashley Hall met for a prearranged school visit with 01 02 03 12 at 12 Dickinson Drive, Sandy Hook. It had been confirmed with 01 02 03 12 that they were in agreement with the plan for the visit, but that they were not interested in attending at this time.

The 01 02 03 12 had not been present for any of the group meetings held for the families of the deceased and had not received any of the information that was provided by the State Police during those meetings. Detective Jewiss and I subsequently provided them with the following information:

- a basic review of the timeline of events (dated 1/15/13)
- location of where 01 02 03 12 body was found
- some background history of the shooter and his family

Officer Chapman, 01 02 03 12 was present and discussed specific information pertaining to movements within the school and details specific to 01 02 03 12 with the 01 02 03 12, as did Tpr. Sawyer. The 01 02 03 12 were given some clarification about some of the inaccurate stories and media rumors that were circulating. PA system, the location of the principal and school psychologist, the shooter's entry to the lobby, some clarification of Miss Soto's movements and the shooter's entry to the room. Some clarification of the leaked information that had been put out in the media last month was offered, as well as information regarding any verbalizations from the shooter and the outcome of the investigation into the shooter's reported trip to the high school on the day of the shooting.

The 01 02 03 12 were afforded some time to reflect privately within the classroom prior to clearing the school.

The status of the case remains actively under investigation.
