

PA system, the location of the principal and school psychologist, the shooter's entry to the lobby, some clarification of Miss Soto's movements and the shooter's entry to the room. Some clarification of the leaked information that had been put out in the media last month was offered, as well as information regarding any verbalizations from the shooter and the outcome of the investigation into the shooter's reported trip to the high school on the day of the shooting.

The 11 02 03 12 were afforded some time to reflect privately within the classroom prior to clearing the school.

The status of the case remains actively under investigation.
