On 4/4/13, this Detective again met with 01 02 03 12 at Sacred Heart Church to address some follow-up questions they had pertaining to Total This Detective and 01 02 03 12 discussed, in part, some rumors she had heard about the shooting, some clarification of 01 02 03 12 injuries, some information pertaining to the weapons used by the shooter, and some details about where she had heard that the victims were located within the classroom. Additionally, 01 02 03 12 discussed some confusion they had regarding the Freedom of Information Act and what issues could be disclosed as a result of requests.

On 4/4/13 01 02 03 12 was presented with a box containing the clothing worn by 01 02 03 12 on 12/14/12. 01 02 03 12 signed for the clothing on a JD-CR-18, Inventory of property seized without a search warrant (see attached).
