ACTION TAKEN: On 12/14/2012 at approximately 1300 hours, I was assigned to assist 04 [REDACTED] who was unable to locate 04 [REDACTED] Anne Marie Murphy. 04 [REDACTED] informed me that 04 [REDACTED] was a special education assistant and was assigned to Ms. Soto's classroom. 04 [REDACTED] informed me that 04 [REDACTED] was born in the 1960's, was approximately 5'5, 170lbs, and had short brown hair. 04 [REDACTED] stated that Anne Marie was wearing a plain gold wedding band on her left had with the initials MM on the inside. 04 [REDACTED] informed me that 04 [REDACTED] and Anne Marie's 04 [REDACTED] was en- route to the firehouse from his job site in 04 [REDACTED] provided me with a picture of Anne Marie via a text message, which I then forwarded to Major Hyatt. At approximately 1500 hours, I made contact with 04 [REDACTED] at the firehouse.

At approximately 2200 hours, 04 [REDACTED] and Anne Marie's 04 [REDACTED] appeared at the firehouse. Within a few minutes, 04 [REDACTED] left the firehouse and returned to their residence. 04 [REDACTED] remained at the firehouse for the remainder of the day. I remained at the firehouse with 04 [REDACTED] and another parent, 01 02 03 12, who could not locate his son, 01 02 03 12. On 12/15/2012 at approximately 0015 hours, I provided the notification to 04 [REDACTED] that 04 [REDACTED] Anne Marie Murphy had been killed at the Sandy Hook Elementary School on 12/14/2012. I completed this notification at the Sandy Hook Firehouse and the following individuals were present: Clinician Caroline Diemar, Clinician David Cribbine, and Monsignor Robert Weiss 04 [REDACTED] was then transported to his residence.
