-some details regarding the children transported and the actions of first responders and EMS upon making contact with the victims

It should be noted that, as within many of the decedent families, the 01 02 03 12 were admittedly at different places than one another with their grief and similarly with their desire to know details about the incident, the shooter, and about their daughter as well.

A bullet fragment, located within 01 02 03 12 backpack by 01 02 03 12 b, was turned over to Detectives and was seized and ultimately processed, packaged and placed into evidence upon return to Troop A per State Police protocol (see Exhibit # 00350.)

The status of the case remains actively under investigation.
