Family Meeting Report

**01 02 03 12** Family- 2/13/13 and 6/6/13)

Action Taken:

On 2/13/13, at approximately 1655 hours, this Detective and Detective Jewiss #336 met with family friends of the **01 02 03 12** family **01 02 03 12**, for a prearranged private meeting regarding the ongoing investigation. Present for the meeting were the following persons:

**01 02 03 12**  
**01 02** (Trooper liaison and husband)

Neither the **01 02 03 12** nor the **01 02 03 12** were present for the Group Family Meeting on 1/15/13 and therefore had not directly received any of the information that was provided by the State Police during that meeting. Detective Jewiss and this Detective subsequently provided them, in part, with the following information:

- a basic timeline of events (dated 1/15/13)
- information pertaining to **01 02 03 12** personal property which was returned to the family following the shooting, specifically pertaining to **01 02 03 12** which was located within his backpack
- specific information pertaining to **01 02 03 12** and his location within the classroom

- information pertaining to some statements that were overheard by others within the school
- some available information about the shooter, his movements, where his body was found and his family, whether or not he was on social media
- some information pertaining to what will be contained in the final report, the overall case file and when those reports may be released and available to the public
- information pertaining to the initial theory that there were additional shooters
- clarifying information about some of the misinformation that was circulating pertaining to actions or verbalizations of the victims, other potential targets of the shooter, movements of the shooter on the previous day, the shooter's attendance at the school as a child
- information about the door locks and condition of the doors within the school
- information about the Bushmaster rifle's semi-automatic definition
- information about what the emergency response plan for the school and classroom was
- information about some of the other victims' locations as permitted for release by their families
- information about the children transported to the hospital
- clarifying information about the publicized spreadsheet and what planning the shooter might have put into the incident, when his mother was killed, whether or not any of the weapons were newly purchased, and information gathered that indicated that the shooter had an obsession with mass murder
- information pertaining to the condition of the classroom
- information pertaining to the autopsy and Medical Examiner information, including the administrative time stamps used
- clarifying information pertaining to whether or not the shooter was firing into the parking lot from inside the school

The 01 02 03 12 were provided with paperwork for the 01 02 03 12 family, to include IRS contact information, and a JD-CR-18 for some additional property of 01 02 03 12 that was returned following the meeting.

On 4/18/13, this Detective met with the 01 02 03 12 and returned several pieces of 01 02 03 12 artwork that had been obtained from a bulletin board within the school.

On 6/6/13, at approximately 0900 hours, this Detective again met with 01 02 03 12 to provide some answers and clarification on some questions that the 01 02 03 12 family had. During the meeting, the 01 02 03 12 stated that the 01 02 03 12 have no interest in visiting the school, and no desire to have 01 02 03 12 clothing returned to them at this time. The 01 02 03 12 were provided with information
