Action Taken: On 3/27/13, this Detective met with **01 02 03 12** father of Sandy Hook school shooting victim **01 02 03 12**, following a group informational meeting held at the Newtown Town Hall, 3 Primrose Street, Newtown, CT. This Detective advised that she was following up with an inquiry that had been forwarded to the **01 02 03 12** by their State Police liaison, **01 02** regarding **01 02 03 12** medical records from Danbury Hospital.

**01 02 03 12** stated that he was not going to voluntarily sign a consent for his daughter's medical records at this time and further stated that he did not anticipate that he would have reason to sign one in the future, as the records would have no impact on the outcome of the investigation. This Detective thanked **01 02 03 12** for considering the request and advised him that she would document his position for inclusion in the case file.

The status of the case remains actively under investigation.
