VICTIM AUTOPSY REPORTS

On Saturday, December 15th, 2012, the autopsies of twenty-six victims of the Sandy Hook School shooting were conducted by members of the Office of the Chief Medical Examiner (OCME), 11 Shuttle Road, Farmington, Connecticut. The results of the autopsies are currently being held by State's Attorney Sedensky.

The results of the autopsies reported by the Medical Examiners certified that the cause of death to be:

Twenty-four (24) victims sustained "Multiple gunshot wounds"

**01 02 03 12** sustained "Gunshot wound of neck"

**01 02 03 12** sustained "Gunshot wound of head"

The manner of death for all victims was certified to be "Homicide"
