Private Meeting and School Visit Report

(04 [redacted] Rachel D'Avino)

Action Taken: On 5/24/13, at approximately 0800 hours, this Detective, Newtown Police Officer Jeff Silver and Detective Jewiss #336 met with 04 [redacted] at the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit.

04 [redacted] relayed that because Rachel was new to the school and not from the area, they were not initially aware that she was at all involved with the shooting until Rachel's boyfriend told them that Sandy Hook was a part of Newtown, and was, indeed, the school that she was currently working at.

04 [redacted] was present for the initial Group Family Meeting, and had therefore received some of the investigative information that had been presented to date. Detective Jewiss and this Detective subsequently provided the family with, in part, the following information:

- updated timeline information
- information specific to Rachel and the location where she was found
- information about where the other persons within the classroom were located, as permitted for release by the decedent and survivor families
- some general background information about the shooter and his family
- information about the condition of the classrooms as they were found at the time of the police response
- information about where the gun safe was located within the residence
- clarifying information about whether or not 01 02 03 12 [redacted] was with Rachel

-information about where the shooter parked, how he gained entry to the school and his path of travel once inside the building. It was explained that the order of rooms which the shooting had occurred in was still unknown at this time

04 were afforded some time to reflect privately within classroom 8 prior to clearing the school, and were provided with a copy of a letter with contact information for the IRS in the event that any suspicious activity linked to Rachel's social security number or identity is observed.

The status of the case remains actively under investigation.
