Hammond stated that she initially heard the sounds of children screaming, but that it stopped at some point, and advised that she believes that the screaming was associated with the children that were running out of the building. Hammond stated that she recalls that during the majority of the shooting, the building was early quiet with the exception of the sound of the gunshots.

Hammond was brought to the back of the school where her office and old classroom were located prior to clearing the school.

The status of the case remains actively under investigation.
