04 advised that they had found an additional and unaccounted for bullet hole in the wheel well of Lauren's car. 04 explained that they had sold the car "as is" shortly after the shooting, but that a family friend had identified the additional hole near the tire.

were shown a map indicating where Lauren's vehicle was parked in the school lot on the day of the shooting.

04 were shown where Lauren was found within her classroom, and also relayed information, as permitted by the decedent and survivor families, as to where some of the other victims were located in relation to Lauren.

04 gave permission to share Lauren's location with the other decedent and survivor families. 04 were away were away

04 were advised that the sequence of rooms for the shooting remains undetermined at this point, but are aware of what the two possible scenarios are at this time.

When asked for any critiques that the family had about the way that they have been treated or handled as victims in the tragedy, 04 offered that when notification was made to their family, it was done by someone other than the female Trooper that had been initially assigned to them, due to the fact that she lived somewhere in 03 compared CT, and had already cleared for the night. 04 compared also offered that the Trooper that was assigned had been given misinformation, to include that Lauren was 04.

The status of the case remains actively under investigation.
