Action Taken: On 6/14/13 at approximately 0930 hours, this Detective responded to Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, and met with Newtown Police Department Officer Jeff Silver for a prearranged school visit with 04.

Present for the visit were the following persons:

04 had been present for the initial group family meeting during which much of the investigative information that was known was shared with the decedents' families, and therefore was already aware of the majority of the details that were known with regard to the timeline of events for the morning of the shooting.

Prior to clearing the school 04 were provided, in part, with the following information:

- a basic review of the timeline of events (dated 1/15/13)
- information specific to Dawn, her known actions leading up to the shooting, and the location of where she was found within the school
- some very general background information about the shooter and his family, as well as his attendance at the school

- some clarification of what was known about the shooter's movements, and the fact that the sequence of rooms where the shooting took place remains undetermined at that time
- some information pertaining to the difference between the case file and the final report/summary that will be generated by SA Sedensky
- some information regarding the Medical Examiner's reports/information
- clarification of some information incorrectly released to the media early in the investigation

Several items of Dawn's personal property, as found within her office in the school, were turned over to [REDACTED] 04, and the plan regarding the future return of the remainder of Dawn's personal effects to [REDACTED] 04 was confirmed with [REDACTED] 04. [REDACTED] relayed that, in his opinion, if the shooting had occurred in Dawn's school and she had survived but lost students or staff, she would have never forgiven herself, [REDACTED] 03 04

The status of the case remains actively under investigation.
