-School Visit Report-

01 02 03 12

Action Taken: On 2/12/13 at approximately 1000 hours, this Detective, Detective Jewiss #336 and Officer Silver from the Newtown Police Department responded to the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with 01 02 03 12 mother of S.H.E.S. student 01 02 03 12 mother had been present for the first informational group meeting at which time the majority of the investigative information that was known was shared with the decedents' families. During the visit, 01 02 03 12 asked questions and requested clarification on some information she had received and was provided with, in part, the following:

-clarification of some questions regarding information that had been shared at the group meetings

-information specific to 01 02 03 12 and his location within the classroom

-information pertaining to some of the other victims' locations within the classroom in relation to 01 02 03 12 as permitted for release by their families

-information regarding the movements of the teacher and students in Room 12 (Roig)

-clarification of whether or not a key was present and available to the teacher in 01 02 03 12 classroom

01 02 03 12 and this Detective discussed plans for the return of some of 01 02 03 12 personal property in the near future. 01 02 03 12 walked through the entire school building and specifically asked to see the gymnasium where 01 02 03 12 and the time of the incident prior to clearing the school.

The status of the case remains actively under investigation.
