--School Visit Report--

01 02 03 12

On 6/21/13 at approximately 0900 hours, this Detective, Detective Jewiss #336 and Officer Silver from the Newtown Police Department responded to the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with 01 02 03 12, father of S.H.E.S. student 01 02 03 12 had been present for the first informational group meeting at which time the majority of the investigative information that was known was shared with the decedents' families. During the visit, 01 02 03 12 asked questions and requested clarification on some information he had received and was provided with, in part, the following:

-information specific to where ^{01 02 03 12} was found within his classroom

-information regarding where the two adults were found in the classroom relative to 01 02 03 12

-information pertaining to what children were in close proximity to 2102 03 12, as permitted by the decedents' families

-information regarding the amount of bullet casings that were found in the classroom

-information pertaining to what was known about the survivor and victims' movements and actions within the classroom before, during and after the shooting

-information pertaining to the number of students in Room 12 (Roig)

-clarification of information regarding statements or utterances overheard by staff and a student that are believed to have been made by the shooter and/or a student in one of the classrooms. The possibilities of where the sounds came from were explained and the different versions of what was reportedly heard were relayed

-information pertaining to specific time stamps from the timeline that had been given out at the first group meeting

01 02 03 12

Prior to clearing the school, 01 02 03 12 requested to visit 01 02 03 12 old kindergarten classroom, and also to visit the gymnasium 01 02 03 12

01 02 03 12 had inquired about what time the automated telephone message regarding the incident had gone out over the phone lines and was advised that an answer would be obtained for him. 01 02 03 12 explained that the telephone call was how he had learned of the incident.

01 02 03 12 also inquired as to the height and weight of the shooter at the time of the incident and was again advised that the answers to those questions would be obtained and relayed to him.

On 7/11/13, Detective Jewiss contacted 01 02 03 12 via e-mail and advised that the shooter had a documented height of 6'00" and weight of 112 lbs. Additionally, Det. Jewiss relayed that the initial automated school messenger call went out at 0955 hours, with several additional messages following the first call.

The status of the case remains actively under investigation.
