-School Visit Report-

01 02 03 12 - mother of **01 02 03 12**

Action Taken: On 6/21/13 at approximately 1300 hours, this Detective, Detective Jewiss #336 and Officer Jeff Silver of the Newtown Police Department responded to Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with **01 02 03 12**, mother of **01 02 03 12**

01 02 03 12 had been present for the first, as well as several other informational group meetings at which time the majority of the investigative information that was known was shared with the decedents' families. During the visit, **01 02 03 12** advised that she did not wish to have any investigative or clarifying information relayed to her and only wished to have some time to herself in **01 02 03 12** classroom near where her daughter was found. **01 02 03 12** was provided with the information and was then given the space that she had requested to reflect in classroom #10.

Prior to clearing the school, **01 02 03 12** inquired as to how close in proximity to another child **01 02 03 12** was, due to the fact that the children were very close friends **01 02 03 12** was provided with the requested information, as the other child's family had given permission to share details of her location within the classroom with the families of the other decedents.

The status of the case remains actively under investigation.
