**01 02 03 12**

Action Taken: On 3/27/13 at approximately 0945 hours, this Detective, Officer Jeff Silver from Newtown Police Department and Detective Jewiss #336 responded to the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with **01 02 03 12**

**01 02 03 12** were taken on a detailed walk-through of the incident and numerous questions were asked and answered. **01 02 03 12** were provided with clarifying information pertaining to the activation of the school intercom system as well as clarifying information about the bullet casings and magazines that were found in the school.

**01 02 03 12** expressed some confusion about the information that they had received from the Medical Examiner's Office in comparison to the damage that they had seen to some of **01 02 03 12** personal property that was returned to them. Officer Silver assisted in explaining some information about the bullets and the manner in which they might be deflected and tumble based upon their weight. **01 02 03 12** also expressed concern over the potential for any O.C.M.E. information being released.

**01 02 03 12** walked the impacted hallway to include the rooms where two injured teachers retreated to and discussed some of the damage that they saw within the building with Detectives.

**01 02 03 12** inquired as to the plan for the school in the future and discussed some rumors they had heard with Officer Silver. **01 02 03 12**
