(01 02 03 12 Parents - 02/26/13)

ACTION TAKEN:

On 02/26/13 at approx. 1030 hrs, Det. Rachael Van Ness #1431, Newtown Officer Jeff Silver and I met with 01 02 03 12 at the Sandy Hook Elementary School at 12 Dickinson Drive, Sandy Hook, CT. for a prearranged school visit. 01 02 03 12 had been present at the informational group family meeting that had been held and therefore had already received all of the investigative information that had been given to the decedents' families. 01 02 03 12 were given the opportunity to walk through the impacted areas within the school and were provided, in part, with the following information:

- a basic review of the timeline (dated 01/15/13)
- specific details that were known about 01 02 03 12 including where he was found by 1st responders
- the location of other victims in relation to 01 02 03 12 as approved by some of the other victims' families
- information about the shooter, including some family background, his personal background and details about our search of his home
- details about the actions of the shooter, where he parked his car at the school and what weapons and ammo he was carrying
- clarification of some misinformation and rumors that had been released by the media

We also discussed the FOIA and HIPAA laws with the 01 02 03 12 and their concerns about the eventual release of photos and sensitive case information. They informed us that they were still being contacted by the media, trying to get information from them and their opinions about whether

The 01 02 03 12 were taken to the spot where 01 02 03 12 was found within his classroom and were afforded the opportunity to reflect privately within the classroom prior to clearing the school.
