**ACTION TAKEN:**

On 02/07/13 at approx. 1100 hrs., Det. Rachael Van Ness #1431 and I met with [REDACTED] 01 02 03 12 at their residence at [REDACTED] 01 02 03 12 [REDACTED] 01 02 03 12 mother, [REDACTED] 01 02 03 12 was away, but would be briefed by her husband [REDACTED] 01 02 03 12 was a student in Mrs. D'Amato's classroom and a victim of the Sandy Hook Elementary School shooting. Present for this meeting were the following:

Det. Van Ness and I subsequently provided [REDACTED] 01 02 03 12 with the following information:

- An explanation of how the CT State Police became the Lead Agency in this investigation and the case status
- Timeline of Events (dtd 01/15/13)
- Location [REDACTED] 01 02 03 12 was found and clarifying information specifically about her

- Information about how to request her autopsy report
- Support information concerning how to deal with the "hoax theorists" and the overwhelming incorrect information reported by the media
- Some background history of the shooter and his family, including info dispelling rumors that were incorrectly reported by the media
- Details about the weapons and ammo that the shooter possessed
- Details about the shooter's movements as known at that time

Det. Van Ness and I also offered that **01 02 03 12** could visit the Sandy Hook Elementary School and also receive **01 02 03 12** clothing or a swatch of it if they wanted. We then explained that we were not disclosing any information about any one specific victim until we had met privately with that family and provided that information to them first and then received their approval to share that information with others. **01 02 03 12** subsequently approved to the release **01 02 03 12** location information to other families. In addition, we asked that the information that we discussed be kept in confidence, especially since a majority of it had not been disclosed publicly. Det. Van Ness and I also answered several individual questions and provided **01 02 03** with our contact information before departing at approx. 1210 hrs. This information was then tracked on the Family Folder Checklist in their individual Family Folder.
