**ACTION TAKEN:**

On 05/14/13 at approx. 1437 hrs, Newtown Officer Jeff Silver and I met with [REDACTED] 01 02 03 12 at the Sandy Hook Elementary School at 12 Dickinson Drive, Sandy Hook, CT. for a prearranged school visit. [REDACTED] 01 02 03 12 were joined by their Family Liaison Officer, [REDACTED] 01 02. I then took them on a detailed walk-through of the incident and numerous questions were asked and answered. I told them location information about some other victims, as well as specific information [REDACTED] 01 02 03 12 including where she was found. I also explained what the normal Emergency Response Plan for the school was during a Lockdown Drill and what appeared to happen on 12/14/12.

I also gave [REDACTED] 01 02 03 12 a folder containing [REDACTED] 01 02 03 12 artwork which had been removed from a bulletin board within her classroom.

[REDACTED] 01 02 03 12 were afforded some time to reflect privately [REDACTED] 01 02 03 12 classroom before departing the school.
