ACTION TAKEN:

On 03/04/13 at approx. 1200 hrs, Det. Rachael Van Ness #1431, Newtown Officer Jeff Silver and I met with 01 02 03 12 at the Sandy Hook Elementary School at 12 Dickinson Drive, Sandy Hook, CT. for a prearranged school visit. 01 02 03 12 was joined by LCSW Elizabeth Stern and FBI Victim's Specialist Ashley Hall, although LCSW Stern did not come into the school. 01 02 03 12 was then taken on a detailed walk-through of the incident and numerous questions were asked and answered. 01 02 03 12 was told location information about some other victims, as well as specific information about 01 02 03 12, including where and who found 01 02 03 12 and 01 02 03 12. It was also relayed that additional information concerning 01 02 03 12 injuries might be covered in the Medical Examiner's report, but that we had not received that information yet.

Upon 01 02 03 12 request, he was told some background about the shooter and his weapons. It was also explained that information concerning a possible motive was still undetermined.

01 02 03 12 was also given the I.R.S. SSN Protection Memo and the offer about the return of 01 02 03 12 clothing was extended again. 01 02 03 12 was afforded some time to reflect privately in 01 02 03 12 classroom before departing the school.
