01 02 03 12 (07/18/13)

ACTION TAKEN:

On 07/18/13 at approx. 1030 hrs, Det. Rachael Van Ness #1431, Newtown Officer Jeff Silver and I met with 01 02 03 12 at the Sandy Hook Elementary School at 12 Dickinson Drive, Sandy Hook, CT. for a prearranged school visit. 01 02 03 12 was joined by their Family Liaison Trooper, 01 02 03 12 had been present at some of the informational group family meetings that have been held and therefore had already received most of the investigative information that had been given to the decedents' families. 01 02 03 12 was given the opportunity to walk through the impacted areas within the school and was provided, in part, with the following information:

- a basic review of the timeline (dated 01/15/13)
- specific details that were known about 01 02 03 12, including where he was found by 1st responders
- the location of other victims in relation to 01 02 03 12, as approved by some of the other victims' families
- clarification of some misinformation and rumors that had been released by the media

We also explained to 01 02 03 12 that we were not disclosing any information about any one specific victim until we had met privately with that family and provided that information to them first and then received their approval to share that information with other families. 01 02 03 12 subsequently approved to the release of 01 02 03 12 location information. 01 02 03 12 also asked questions in relation to 01 02 03 12. As many answers as possible about this were provided to her at this time. 01 02 03 12 was afforded the opportunity to reflect privately within the classroom prior to clearing the school.
