**01 02 03 12**

Action Taken: On 5/10/13 at approximately 1300 hours, this Detective and Detective Peters #816 responded to the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, and met with Newtown Police Officer Jeff Silver for a prearranged school visit with **01 02 03 12**

**01 02 03 12** had been present for the initial as well as several follow-up group informational meetings during which time the decedent families were provided with the majority of the known investigative information. **01 02 03 12** was provided with, in part, the following information:

- information specific to **01 02 03 12** and her location within her classroom
- information pertaining to where other victims were in proximity to **01 02 03 12**, as permitted by the survivor and decedent families
- a basic review of some items from the timeline (dated 1/15/13)
- information pertaining to what has been stated by some of the surviving witnesses

**01 02 03 12** was provided with answers to some questions he had as he walked the impacted hallway prior to clearing the school.

The status of the case remains actively under investigation.
