- information specific to Dawn's proximity to Mary
- a review of the timeline pertaining to the shooter's movements once inside the building
- clarification of the circumstances surrounding the use of the school intercom system
- information pertaining to the Medical Examiner's reports
- clarification of some of the rumor and misinformation that developed early in the media
- information pertaining to what other witnesses and victims have relayed
