04 was given a walk-through of the impacted hallway, inclusive of Vicki's classroom and were also provided with clarifying details pertaining, in part, to the following information:

- information pertaining to the possible scenarios for the shooter's movements/path of travel inside the hallways
- clarifying information about what the people in the main office reported seeing the shooter do
- a reiteration of some of the media rumors that are/were circulating about actions and statements made by victims
- clarification of some information that was leaked during a conference
- information pertaining to the testimony of Dr. Begg from Danbury Hospital
- issues and concerns surrounding the hoax and conspiracy theories
