Action Taken: On 6/5/13 at approximately 1330 hours, this Detective responded to the Sandy Hook Volunteer Fire Department and met with 04

04

transported up the driveway to the school where we were met by Detective Jewiss #336 and Officer Silver from the Newtown Police Department.

04 was shown a map indicating where Vicki was found, and was then taken to the classroom and shown the location that corresponded to the map. 04 was subsequently provided, in part, with the following information:

-information pertaining to the movements and location of the surviving children in and from Room 10

-information specific to Vicki's known movements and actions

-information pertaining to the location of other victims in proximity to Vicki, as permitted by the other decedent and survivor families

-a repeat of clarifying information pertaining to some of the rumors that had circulated about victims, Victoria included, confronting or diverting the shooter

-information pertaining to how the shooter was carrying his ammunition and how it was configured and how much he had in total

-information pertaining to the location of the shooter's rifle as found within the classroom

-confirmation that the shooter's gunshot wound was self inflicted

-clarification of whether or not there were victims transported and if Vicki was one of them

-information pertaining to how long after the incident the victims/decedents were removed from the school

-information pertaining to what the surviving students have stated and if they relayed whether or not Vicki had said anything -information as to the condition of the room during the visit versus at the time of the shooting and the purpose or cause for removal of some items and materials

-information pertaining to bullets that struck vehicles out in the parking lot from inside Room #10

-information pertaining to verbalizations or utterances overheard by a teacher and student which are believed to have been made by the shooter and/or students and teachers

-information pertaining to what was heard by witnesses during the incident

-information pertaining to what can be heard on the 911 calls

04 inquired as to whom has access to the school and specifically the locked portion of the impacted hallway. 04 completed a walk through of the impacted area and a basic review of the timeline was provided during it.

04 inquired about the injuries sustained by 04 and and the other victims, which is not information known by the State Police, and was advised that Dr. Carver, Chief Medical Examiner, had put out early on in a press conference that all of the victims had multiple gunshot wounds and that the O.C.M.E. maintains that documentation and will release it only to the respective families.

04 was afforded some time to reflect privately within Vicki's classroom prior to clearing the scene.

The status of the case remains actively under investigation.
